ORDER

On February 10, 2025, the Commission issued an Order directing Lindsey & Elliott Gas Company (Lindsey & Elliot) to show cause as to why it should not be subject to penalties for failure to comply with the Commission’s July 29, 2024 final Order in this proceeding.<sup>1</sup> Lindsey & Elliot submitted a response within the required timeframe on February 14, 2025;<sup>2</sup> however, the response initially contained incorrect documentation.

Following further communication and instructions from Commission Staff, Lindsey & Elliot submitted the required documentation on February 21, 2025.<sup>3</sup> While the filing was one day past the stated deadline, Lindsey & Elliot actively engaged with Commission Staff to resolve the issue.

The Commission finds that Lindsey & Elliot has now complied with the Order entered on February 10, 2025, and no further action is necessary.

IT IS THEREFORE ORDERED that:


1. Lindsey & Elliott is found to be in compliance with the Show Cause Order issued on February 10, 2025.


2. This case is closed and removed from the Commission's docket.
