O R D E R

On December 18, 2025, Lindsey & Elliott Gas Company (Lindsey & Elliott) filed a motion¹ that requested the Commission confirm its tariff rate set out in the final Order entered in this matter on July 29, 2024. As part of this final Order, the Commission instructed Lindsey & Elliott to file revised proposed tariff sheets within 18 months of the date of service of the Order, including information required to complete forms that were attached as an Appendix to the final Order and information relating to nonrecurring charges.²

In support of its motion, Lindsey & Elliott stated that after consultation with Commission Staff, Lindsey & Elliott has no desire to change, modify, or increase any of its tariff rates from those that were previously approved in the Commission's final Order entered on July 29, 2024, and therefore, Lindsey & Elliott will not be filing any additional documents pursuant to the final Order.³ Therefore, in lieu of filing information for an adjustment to its rates within 18 months from the date of service of the final Order, Lindsey

& Elliott has filed this motion. Lindsey & Elliott further stated that it understands that if it desires to make any changes in its rates in the future that it will need approval from the Commission before implementing such rates.⁴

Based upon the motion and being otherwise sufficiently advised, the Commission finds that Lindsey & Elliott established good cause to grant its motion to confirm the tariff rates set out in the final Order entered on July 29, 2024, given the fact that Lindsey & Elliott does not desire to modify its previously approved tariff rates at this time. The Commission further finds that by filing this motion, Lindsey & Elliott has satisfied the Commission's directive to file revised tariff sheets and information within 18 months of the date of service of the final Order.

IT IS THEREFORE ORDERED that:

1. Lindsey & Elliott's motion to confirm its tariff rates as set out in the Commission's final Order entered on July 29, 2024, is granted.
2. Lindsey & Elliott is in compliance with the final Order entered on July 29, 2024, and is therefore relieved from further filing requirements as it relates to this case.
3. This case is closed and removed from the Commission's docket.
