## COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION TO CUMBERLAND COUNTY WATER DISTRICT

Cumberland County Water District's (Cumberland District), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on October 3, 2023. The Commission directs Cumberland District to the Commission's July 22, 2021 Order in Case No. 2020-00085<sup>1</sup> regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the

response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Cumberland District shall make timely amendment to any prior response if Cumberland District obtains information that indicates the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Cumberland District fails or refuses to furnish all or part of the requested information, Cumberland District shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Cumberland District shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. List the name of each current Cumberland District commissioner, their current residential address, the date they were approved by the Cumberland County Fiscal Court, and the date on which their term expires.

2. Provide a map of Cumberland District's territory.

- 3. Provide any changes to the membership of the Cumberland District Board of Commissioners since April 4, 2023, or a statement that there have been no changes to the Board.
- 4. Provide any orders, resolutions, or minutes of the Cumberland County Judge Executive or Cumberland County Fiscal Court that address appointments to the Cumberland District's Board of Commissioners since April 4, 2023.
- Provide all orders, resolutions, or minutes of the Cumberland County Judge
   Executive or the Cumberland County Fiscal Court that address the appointments of
   Cumberland District's current Board of Commissioners.
- 6. Provide all orders, resolutions, or minutes of the Cumberland County Judge Executive or the Cumberland County Fiscal Court that address the compensation or benefits of Cumberland District's current Board of Commissioners within the past three years.
- 7. Provide the salary of each current commissioner as well as any change to said salary since April 4, 2023.
- 8. Provide the benefits received by each of the current commissioners as well as any changes in the benefits since April 4, 2023.
- Provide any changes to the terms of each current commissioner since April
   4, 2023.
- 10. Provide documentation of any trainings attended by each commissioner since April 4, 2023, as well as any upcoming trainings each commissioner is scheduled to attend.

- 11. Provide minutes from every Cumberland District's Board of Commissioners' meetings from April 2023 to the present. Consider this an ongoing request throughout this proceeding.
- 12. Provide the Cumberland District's Board of Commissioners' current practices and procedures for appointing members to the Board.
