ORDER

On June 30, 2025, Black Mountain Water District (Black Mountain District) filed a motion for extension of time (Motion) to file an adjustment of rates as ordered by the Commission.¹ Black Mountain District asked for a 120-day extension to file said application.²

On August 20, 2024, the Commission issued an order requiring Black Mountain Utility District (Black Mountain District) to provide its 2020 Annual Report within three months from the Order.³ In Case No. 2023-00202, Commission granted an extension for good cause extending the due date of the filing of an annual report related to the water loss surcharge and water loss improvement progress until July 15, 2025.⁴ On August 20, 2024, the Commission also ordered Black Mountain District to file an application for a

general rate case or an application pursuant to 807 KAR 5:076 by no later than July 1, 2025, using a 2024 test year or provide a statement with an explanation that such an application is unnecessary.⁵

As grounds for the Motion, Black Mountain District cited substantial operational challenges that have prevented timely compliance with the deadline established by the Commission's August Order, which required filing by July 1, 2025.⁶ Specifically, Black Mountain District referenced recent turnover among its commissioners and its resulting inability to provide the Kentucky Rural Water Association with the necessary information to complete the rate studies required for the application.⁷

Having considered the motion and being otherwise sufficiently advised, the Commission finds that good cause exists to grant the requested 120-day extension. The Commission recognizes that Black Mountain District has experienced unforeseen complications beyond its control, which made difficult timely submission of the application by the July 21, 2025 deadline.

IT IS THEREFORE ORDERED that:

- 1. Black Mountain District's Motion for Extension of Time is granted.
- 2. Black Mountain District shall file an application for a general rate case or an application pursuant to 807 KAR 5:076 by no later than October 29, 2025, using a 2024 test year or provide a statement with an explanation that such an application is unnecessary.
