<u>ORDER</u>

A hearing in the above-styled matter was held on Wednesday, February 7, 2024, at 1 p.m. Eastern Standard Time. At the conclusion of the witness testimony, Siting Board counsel requested to file post-hearing requests for information and counsel for Dogwood Corners LLC (Dogwood Corners) requested to file a post-hearing brief after responses to requests for information have been filed.

From the bench, the Commission overruled the Motion Objecting to the Witness List filed by the Dogwood Corners on February 5, 2024. The Commission noted that the witness list was filed by the Christian County Fiscal Court (the Fiscal Court) five days prior to the hearing and was in compliance with the applicable administrative regulations and statutes. The Commission, governed by KRS 278.310,¹ held that the Christian County Judge Executive could testify to facts within his personal knowledge.

¹ All hearings and investigations before the commission or any commissioner shall be governed by rules adopted by the commission, and in the conduct thereof neither the commission nor the commissioner shall be bound by the technical rules of legal evidence.

IT IS THEREFORE ORDERED that:

1. Post-hearing requests for information, if any, shall be filed on or before February 9, 2024.

2. Responses to post-hearing requests for information shall be filed on or before February 16, 2024.

3. Counsel for Dogwood Corners shall file a memorandum brief in support of Dogwood Corners post-hearing position on or before February 23, 2024.

4. Intervenors shall file a memorandum brief on or before February 23, 2024.

12:01 a.m. Eastern Standard Time, February 24, 2024.
