SITING BOARD STAFF'S POST-HEARING REQUEST FOR INFORMATION
TO DOGWOOD CORNERS LLC

Dogwood Corners LLC (Dogwood Corners), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on February 16, 2024. The Siting Board directs Dogwood Corners to the Commission's July 22, 2021, Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the

person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Dogwood Corners shall make timely amendment to any prior response if Dogwood Corners obtains information that indicates the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Dogwood Corners fails or refuses to furnish all or part of the requested information, Dogwood Corners shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Dogwood Corners shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Provide the names of the adjacent landowners that Dogwood Corners, Oriden, or Edelen Renewables did not have any contact with at all to inform them about the project.

2. Provide the results from the Kentucky Biological Assessment Tool run that was conducted by the Office of Nature Reserves.

3. Provide the IPAC review that was conducted.
4. Provide each assignment of lease for each individual parcel in this matter from Oriden to Dogwood Corners.
5. Provide the length and voltage for the connector line connecting parts of the project.
6. Provide a detailed description of how the new substation will connect to the TVA transmission line, including but not limited to the voltage of any utilized lines.
7. Provide a comparison of the cost of this project, including land acquisition, versus alternatives considered including but not limited locating the project in the area of the abandoned mine.
8. Provide how many times Richard Kirkland have completed a Property Impact Report for Oriden.
