ORDER

On November 13, 2024, Kenergy Corp. (Kenergy) filed a motion requesting that the Commission schedule a virtual informal conference (IC) for the purpose of discussing how Kenergy’s technical software functions and to answer questions about the software. Kenergy also requested an extension to respond to Staff’s Third Rehearing Request for Information (Staff’s Third Rehearing Request). Kenergy requested to extend the deadline for responses until ten days after the conclusion of the IC.

Based upon the motion, the Commission finds that Kenergy established good cause to schedule an IC, and therefore the motion should be granted. An IC is scheduled on December 2, 2024, at 11 a.m. Eastern Standard Time. Commission Staff will contact participants by electronic mail to provide details for joining the conference by video link.

The Commission further finds that Kenergy’s motion for an extension of time in which to submit its response to Staff’s Third Rehearing Request until ten days after the IC should be granted.

IT IS THEREFORE ORDERED that:

1. Kenergy’s motion for an IC is granted.
2. Kenergy’s motion for an extension of time is granted.


3. An IC is scheduled on December 2, 2024, at 11 a.m. Eastern Standard Time.
