# <u>O R D E R</u>

On September 14, 2023, Valley Gas, Inc. (Valley Gas) filed, in accordance with its

Purchased Gas Cost Adjustment (PGA) Tariff, its Gas Cost Recovery (GCR) rate report

to be effective October 1, 2023. Valley Gas's previous GCR rate was approved in Case

No. 2023-00186.<sup>1</sup>

# LEGAL STANDARD

The Commission's standard of review for GCR rates is well settled as stated in

KRS 278.274(1):

In determining whether proposed natural gas utility rates are just and reasonable, the commission shall review the utility's gas purchasing practices. The commission may disallow any costs or rates which are deemed to result from imprudent purchasing practices on the part of the utility.

Further, the utility has the burden to prove the rates are just and reasonable and

the Commission may reduce the purchased gas component of the utility's rates or the

rates charged by an affiliated company to the extent the amount is deemed to be unjust

or unreasonable.<sup>2</sup>

#### DISCUSSION

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that Valley Gas's GCR report includes a revised rate designed to pass on to its customers it expected change in gas costs. Valley Gas's GCR report sets out an Expected Gas Cost (EGC) of \$4.0385 per Mcf, which is an increase of \$0.3487 per Mcf from the previous EGC of \$3.6898 per Mcf. Valley Gas's GCR report sets out no Refund Adjustment. Valley Gas's GCR report sets out a current quarter Actual Cost Adjustment (ACA) of \$0.9210 per Mcf. Valley Gas's total ACA is \$1.3794 per Mcf, which is an increase of \$1.0029 per Mcf from the previous total ACA of \$0.3765 per Mcf.

Based on the calculations above, the Commission finds that Valley Gas's GCR rate is \$5.4179 per Mcf, which is an increase of \$1.3516 per Mcf from the previous GCR rate of \$4.0663 per Mcf. The Commission further finds that the rate set forth in the Appendix to this Order is fair, just and reasonable and shall be approved for service rendered by Valley Gas on and after October 14, 2023. Valley Gas did not provide the 30 days' notice required for its rate to be effective October 1, 2023.

The Commission finds that Valley Gas should file its quarterly GCR rate reports to the Commission with at least 30 days' notice pursuant to its Purchased Gas Cost Adjustment Clause Tariff so that it may be processed in a timely manner. Failure to file quarterly GCR rate reports in a timely manner in future filings may adversely affect the timely processing of Valley Gas's GCR rate reports and may result in a possible investigation due to failing to comply with its Tariff.

For the purpose of transparency and to maintain a record of information for future use, the Commission finds that Valley Gas shall submit all invoices it receives along with

its monthly usage reports for each month of the reporting period when it files its future GCR rate reports. Valley Gas's future GCR reports shall also include the additional data information previously provided as a supplemental filing on June 13, 2018, in Case No. 2018-00177<sup>3</sup> as it pertains to the calculation of the future GCR rate along with the monthly storage injection and withdrawal information from Constellation. Should Valley Gas purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports, then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Valley Gas and set forth in the Appendix to this Order are approved for service rendered on and after October 14, 2023.

2. Valley Gas's shall submit all invoices it receives along with its monthly usage reports for each month of the reporting period when it files its future GCR rate reports.

3. Within 20 days of the date of service of this Order, Valley Gas shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.

4. This case is closed and removed from the Commission's docket.
