## ORDER

A hearing in the above-styled matter was held on Wednesday, May 22, 2024. At the conclusion of the witness testimony, a procedural schedule was established that provided for post-hearing requests for information and briefing.

At the hearing, the Commission addressed Sierra Club's May 20, 2024 *pro hac vice* motions in which Sierra Club moved the Commission to admit *pro hac vice* Patrick Woolsey, an attorney whose office is in California, and Nihal Shrinath, an attorney whose office is in California, to practice law before the Commission on behalf of Sierra Club in association with Joe Childers, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case. In support of the request, Patrick Woolsey and Nihal Shrinath have shown that they are members in good standing of another state bar and have been certified to practice before the Commission in this case by the Kentucky Bar Association under Kentucky Supreme Court Rule 3.030(2). In addition, Patrick Woolsey and Nihal Shrinath have agreed to be subject to the jurisdiction and rules of the Commission and the Kentucky Bar Association. The Commission, from the bench, granted Patrick Woolsey and Nihal Shrinath admitted *pro hac vice* for the purpose of representing Sierra Club in association with Joe Childers in the above-styled proceeding, provided that Joe

Childers or another member of the Kentucky Bar Association acts as co-counsel and is present at all proceedings before this Commission.

At the hearing, Kentuckians for the Commonwealth and Kentucky Resources Council (jointly, Joint Intervenors) requested that the Commission take administrative notice of the Federal Register Vol. 88, No. 94 from May 16, 2023. No parties objected to this request. From the bench, the Commission granted Joint Intervenors' request.

## IT IS THEREFORE ORDERED that:

- 1. Sierra Club's May 20, 2024 pro hac vice motions are granted.
- 2. Joint Intervenors' request that the Commission take administrative notice of the Federal Register Vol. 88, No. 94 is granted.
- 3. Post-hearing requests for information, if any, shall be filed on or before May 31, 2024.
- 4. Responses to post-hearing requests for information shall be filed on or before June 21, 2024.
- 5. Any party shall file supplemental post-hearing comments, if any, on or before July 2, 2024.
- 6. Any party shall file its response, if any, to other parties' supplemental posthearing comments on or before July 19, 2024.
- 7. Commission Staff's Report on Big Rivers Electric Corporation's 2023 Integrated Resource Plan shall be filed into the record no later than August 2, 2024.
- 8. Any party desiring to file written comments regarding Commission Staff's Report shall do so no later than August 23, 2024.

9.	All provisions of the Commission's November 3, 2023 Orders not in conflict	
with the provisions of this Order shall remain in effect.
