ORDER

On November 20, 2023, the Commission, on its own motion, initiated a formal review of the adequacy of the Telecommunications Relay Service (TRS) fund surcharge. Pursuant to the Commission's Order in Case No. 2017-00358¹ the Commission conducts a formal review of the TRS fund on an annual basis to determine whether adjustments to the surcharge are necessary to reduce the potential for large balance shortfalls and overages.

All local exchange carriers and commercial mobile radio service providers were served with a copy of the November 20, 2023 Order and were provided the opportunity to file comments regarding this proceeding. Only the Kentucky Broadband & Cable Association (KBCA) filed comments. KBCA's only comment was to recommend that the Commission, if it ordered a change in the surcharge, order the change effective for carriers' next billing cycle and not effective on the date of entry of any Order changing the surcharge.

Currently, the TRS surcharge is \$0.01 per month. The Commission seeks to match collections with expenses, to the extent possible. The TRS program costs vary

monthly because they are based, in part, on TRS usage. The TRS surcharge revenue varies monthly because it is based on the number of access lines served by the carriers who collect and remit the surcharge.

Since the Commission started its annual review of the TRS fund balance, the fund has been experiencing an annual decline. Recently, that trend has reversed. At the beginning of December 2022, the balance of the TRS fund was \$770,418; the balance at the beginning of December 2023, was \$1,079,716, an increase of approximately \$309,298. The increase continued into 2024; at the beginning of August 2024, the balance of the TRS fund was \$1,375,506.

The primary cause of the increase in the TRS fund balance appears to be a decline of usage minutes for TRS and captioned telephone services (CapTel), which are the two services offered by the TRS vendor, Hamilton Relay. Hamilton Relay bills the Commission on a per minute basis for TRS and CapTel. The increases in the fund reverse a several year trend of under collection for the fund. In 2022 the monthly average of combined TRS and CapTel minutes was 12,166; in 2023 the average was 8,781 minutes; and for 2024 to date, the average was 7,334 minutes. While both TRS and CapTel minutes declined since 2022, CapTel experienced a steeper decline, going from a monthly average in 2022 of 6,453 minutes to a monthly average of 2,589 minutes in 2024 to date. It appears, on information and belief, that the decline in minutes for CapTel can be attributed, in part, to customers transitioning to internet protocol (IP) based services and not relying upon the public switched telephone network (PTSN) for connecting their devices. Other CapTel customers may also have difficulty with their devices if their system is converted to a voice over IP system and their devices relied

upon the analog PTSN. Nonetheless, and despite the decline in usage, providing, funding, and maintaining the TRS and CapTel is not only required by statute, it also still provides a valuable lifeline for many residents, particularly seniors, veterans, and individuals with hearing loss, who may face barriers to accessing digital communication services.

The Commission finds that despite the increasing balance of the TRS fund the TRS surcharge should remain at \$.01 per month. The Commission also finds that it will no longer conduct the formal annual review of the fund, established in Case No. 2017-00358. Instead, the Commission will monitor the fund internally and will order changes to the surcharge as is necessary.

IT IS THEREFORE ORDERED that:

1. The TRS surcharge shall remain at \$0.01 per month.
2. Carriers shall continue to remit the TRS surcharge monthly via the online portal established by the Commission.
3. The Commission shall no longer conduct a formal annual review of the TRS fund.
4. A copy of this Order shall be served on all local exchange carriers and commercial mobile radio service providers in Kentucky.
5. This case is closed and removed from the Commission's docket.
