#### ORDER

On December 6, 2023, the Commission initiated (1) the six-month review of Kentucky Power Company's (Kentucky Power) environmental surcharge for the expense periods ending December 31, 2019, June 30, 2020, December 31, 2020, December 31, 2021, June 30, 2022, and December 31, 2022, and (2) the two-year review of Kentucky Power's environmental surcharge for expense periods ending June 30, 2021, and June 30, 2023. The Commission established a procedural schedule by Order dated December 6, 2023, that set out dates for timely and orderly processing of the case.

The Commission, on its own motion, finds that the procedural schedule established on December 6, 2023, should be amended to afford Commission Staff additional time to prepare and file requests for information. Specifically, the Commission finds that procedural schedule dates should be amended as reflected in the Appendix.

#### IT IS THEREFORE ORDERED that:

1. The procedural schedule established on December 6, 2023, is amended.

- 2. The amended dates to the procedural schedule are set forth in the Appendix attached to this Order.
- 3. All provisions of the Commission's December 6, 2023 Order that are in conflict with the provisions of this Order are vacated, and all other provisions not in conflict with the provisions of this Order shall remain in effect.
