ORDER

On January 10, 2024,¹ Powell's Valley Water District (Powell's Valley District) filed an application with the Commission, pursuant to 807 KAR 5:076, requesting an adjustment to its water and sewer rates.² The Commission established a procedural schedule by Order dated February 5, 2024, that, among other things, requires Commission Staff to file with the Commission and serve upon all parties of record a written report (Commission's Staff Report) containing its findings and recommendations regarding Powell's Valley District's requested water and sewer rate adjustment, no later than May 21, 2024.

On April 22, 2024, Commission Staff issued a Third Request for Information (Staff's Third Request), with a required response date no later than April 30, 2024.³

Powell's Valley District did not respond to all requests for information by April 30, 2024, as ordered in Staff's Third Request. Powell's Valley District stated in one of the responses that, "The district is still reviewing the billing information. We will have it by May 3, 2024, and send it in." On May 16, 2024, Powell's Valley District filed its response to Staff's Third Request. Due to the delay in filing by Powell's Valley District, the Commission, on its own motion, found that the procedural schedule established on February 5, 2024, should be amended to afford Commission Staff additional time to review Powell's Valley submission and prepare the Commission Staff's Report. Specifically, the Commission found that the date for filing the Commission Staff's Report should be extended to June 14, 2024.

During Commission Staff's review of the submitted responses, additional issues were discovered that require additional time to adequately determine Powell's Valley revenue requirement. The Commission, on its own motion, finds that the procedural schedule established on February 5, 2024, and amended May 21, 2024, should be amended to afford Commission Staff additional time to prepare and file the Commission Staff's Report. Specifically, the Commission finds that the date for filing the Commission Staff's Report should be extended to July 2, 2024.

After Commission Staff's Report is filed on or before the amended deadline of July 2, 2024, Powell's Valley District will have 14 days to file a written response to Commission Staff's Report.⁵ If Powell's Valley District does not file written objections to a finding

contained in Commission Staff's Report within 14 days after the date of the filing of Commission Staff's Report, it shall be deemed a waiver of all objections to that finding.⁶

IT IS THEREFORE ORDERED that:

- 1. The procedural schedule established on February 5, 2024, and amended May 21, 2024, is amended.
 - 2. Commission Staff's Report shall be filed no later than July 2, 2024.
- Powell's Valley District shall file its written response, if any, to Commission
 Staff's Report within 14 days of the filing of the Commission Staff's Report.
- 4. All provisions of the Commission's February 5, 2024 Order and May 21, 2024 Order, that are in conflict with the provisions of this Order are vacated, and all other provisions not in conflict with the provisions of this Order shall remain in effect.
