## ORDER

A hearing in the above-styled matter was held on May 21, 2024. At the conclusion of the witness testimony, a procedural schedule was established that provided for post-hearing requests for information and briefing.

At the beginning of the hearing, the Commission addressed a motion filed on April 9, 2024 by Kentucky Solar Energy Society and Kentuckians for the Commonwealth (jointly, Joint Intervenors) which moved the Commission for leave to file Corrected Responses to the March 22, 2024 Request for Information from Duke Energy Kentucky, Inc (Duke Kentucky). In support of this motion, Joint Intervenors stated that counsel discovered the verification of their witness, Dr. Richard McCann, was inadvertently omitted. The Commission, from the bench granted Joint Intervenors' request for leave to file these responses.

At the hearing, Joint Intervenors requested that the Commission take administrative notice of the Clean Air Act (CAA) Section 111(b) and 111(d). No parties objected to this request. From the bench, the Commission granted Joint Intervenors' request. The Commission, from the bench, also granted Joint Intervenors' request to file errata testimony for Dr. Richard McCann.

## IT IS THEREFORE ORDERED that:

- 1. Joint Intervenors' April 9, 2024 Motion is granted.
- 2. Joint Intervenors' request that the Commission take administrative notice of the Clean Air Act (CAA) section 111(b) and 111(d) is granted.
- 3. Post-hearing requests for information, if any, shall be filed on or before May 24, 2024.
- 4. Responses to post-hearing requests for information shall be filed on or before June 7, 2024.
- 5. Joint Intervenors shall file errata testimony for Dr. Richard McCann by June 7, 2024.
- 6. All parties shall file a memorandum brief, should they choose to do so, on or before June 26, 2024.
- 7. All parties shall file any post-hearing response briefs, should they so choose to do so, on or before July 18, 2024.
- 8. This case shall stand submitted for a decision by the Commission effective 12:01 a.m. Eastern Daylight Time, July 19, 2024.
