ORDER

On March 27. 2024, the Kentucky General Assembly, during the 2024 Regular Legislative Session, enacted Senate Joint Resolution 175 (SJR 175).¹ The Governor signed SJR 175 signed on April 4, 2024, and it was enrolled with the Kentucky Secretary of State the same day. A copy SJR 175 is appended to this Order.

SJR 175 is a joint resolution, "facilitating the deployment of broadband internet service to unserved and underserved citizens in the Commonwealth and declaring an emergency." SJR 175 states that access to broadband internet service in rural areas of the Commonwealth places unserved and underserved citizens at a disadvantage and recounts that funds from the Broadband Equity, Access, and Deployment (BEAD) Program and the Rural Digital Opportunity Fund (RDOF) that will be used to assist in deploying broadband internet service to unserved and underserved areas. SJR 175 states that the deployment of broadband internet access will require attaching to utility poles.

SJR 175 acknowledges that the Commission, in this docket, has been holding stakeholder meetings on pole attachment delays and exhorts the Commission that it must

make every effort to, "streamline the process and remove unnecessary delays in how attachment requests by broadband service providers are received and processed by the utilities that own the utility poles..."

SJR 175 directs the Commission to promulgate emergency regulations, or emergency amendments to existing regulations, on pole attachments not later than 60 days after the effective date of SJR 175. The regulations, at a minimum, must: (1) remove any unreasonable utility pole attachment-related impediments to the deployment of broadband service; (2) establish parameters to expedite the processing of pole attachment requests for unserved and underserved areas of Kentucky in accordance with the BEAD Program and other government-funded initiatives; (3) reduce the backlog of utility pole attachment requests; and (4) direct pole owning utilities to file tariff conforming to the emergency regulations. The Commission is to ensure that any new or amended regulations tailored to advance the deployment of broadband service in unserved and underserved areas does not result in "an undue burden in processing pole attachment requests for service in served areas of the Commonwealth."

SJR 175 also requires the Commission to initiate a docket on utility pole attachment issues to receive comments from the affected parties and find resolutions that will expedite pole attachment requests. That docket is to remain open until all attachment requests funded by the BEAD Program, RDOF, state broadband grants, and local direct broadband deals are processed and completed. The Commission will initiate that proceeding by separate Order.

The Commission finds that emergency amendments to 807 KAR 5:015 is the most reasonable and efficient method to comply with SJR 175. The Commission also finds

that this proceeding is an appropriate forum to receive proposals from stakeholders and pole owners regarding proposed amendments to 807 KAR 5:015 that will accomplish the dictates of SJR 175. The Commission will allow parties and stakeholders to this proceeding to file with the Commission proposed amendments to 807 KAR 5:015. The proposals will be discussed at an informal conference conducted similar to the format that have previously occurred in this proceeding.

The Commission must file emergency regulations on or before June 3, 2024, which will require a shortened procedural schedule. The Commission therefore finds that proposed amendments should be filed no later than April 19, 2024, and an informal conference should be held on April 26, 2024, to discuss the proposed amendments.

IT IS THEREFORE ORDERED that:

- 1. No later than April 19, 2024, stakeholders and parties to this proceeding may file proposed amendments to 807 KAR 5:015.
- 2. An informal conference is scheduled on April 26, 2024, at 9 a.m. Eastern Daylight Time at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.
- 3. Commission Staff will contact participants by electronic mail to provide details for joining the conference by video link.
- 4. Parties and other participants who plan to attend the informal conferences shall, no later than two days before the informal conference, contact J.E.B. 2	to unserved and underserved citizens in the Commonwealth and declaring an emergency.
3	WHEREAS, access to broadband internet service has become critical for social and
4	economic prosperity because it links the citizens of the Commonwealth to each other and
5	to other parts of the world; and
6	WHEREAS, the lack of access to broadband internet service, which is
7	predominantly a problem in the rural areas of the Commonwealth, places unserved and
8	underserved citizens in those areas at a significant disadvantage; and
9	WHEREAS, the National Telecommunications and Information Administration
0	allocated \$1.1 billion to the Commonwealth in the Broadband Equity, Access, and
1	Deployment (BEAD) Program that will be used to deploy broadband internet service to
12	unserved and underserved residents throughout the Commonwealth; and
13	WHEREAS, another \$157 million will be available for network expansion through
4	the Rural Digital Opportunity Fund and state and local broadband initiatives that will
15	help bring high-speed broadband internet service to every area and every citizen of the
6	Commonwealth, regardless of that citizen's location or household income; and
7	WHEREAS, broadband internet service providers are motivated to begin deploying
8	broadband internet service to unserved and underserved citizens, which requires attaching
9	the necessary fiber optic cables to utility poles throughout the Commonwealth and
20	comply with the funding and performance guidelines set by the BEAD Program and other
21	government-funded broadband initiatives; and
22	WHEREAS, since January 5, 2024, the Public Service Commission has been
23	hosting stakeholder meetings on pole attachment delays; and
24	WHEREAS, every effort must be made by the Public Service Commission to
25	streamline the process and remove unnecessary delays in how attachment requests by
26	broadband service providers are received and processed by the utilities that own the
27	utility poles:

- Be it resolved by the General Assembly of the Commonwealth of Kentucky:
- 3 → Section 1. The General Assembly of the Commonwealth of Kentucky hereby
- 4 directs the Public Service Commission to promulgate emergency administrative
- 5 regulations pursuant to KRS Chapter 13A on utility pole attachments not later than 60
- 6 days after the effective date of this Resolution that shall at a minimum:
- 7 (1) Remove any unreasonable utility pole attachment-related impediments to the 8 deployment of broadband service throughout the Commonwealth;
 - (2) Establish parameters to expedite the processing of pole attachment requests for unserved and underserved areas of the Commonwealth in accordance with the BEAD Program and other government-funded broadband initiatives, as authorized by the bipartisan Infrastructure Investment and Jobs Act, Pub. L. No. 117-58, and other government-funded broadband initiatives;
 - (3) Reduce the backlog of utility pole attachment requests; and
 - (4) Direct utilities that own poles to file new tariffs if necessary to conform with the emergency administrative regulations promulgated by the Public Service Commission no later than 60 days after the effective date of the emergency administrative regulations. In promulgating administrative regulations under this section, the Public Service Commission shall ensure that any new or amended administrative regulations are tailored to advance the buildout of broadband service to unserved and underserved areas and does not result in an undue burden in processing pole attachment requests for service in served areas of the Commonwealth.
 - → Section 2. The Public Service Commission shall initiate a docket on utility pole attachment issues to receive comments from the affected parties and find resolutions that will expedite utility pole attachment requests and the deployment of broadband throughout the Commonwealth. Small telephone utilities, as defined in KRS 278.516, may elect to participate in this docket either independently or collectively, but shall not

- be required to participate in this proceeding. The docket shall remain open until all utility
 - 2 pole attachment requests funded by the BEAD Program, the Rural Digital Opportunity
 - 3 Fund, state broadband grants, and local direct broadband deals are processed and the
 - 4 projects are completed.
 - 5 → Section 3. Beginning September 30, 2024, and quarterly thereafter, the Public
 - 6 Service Commission shall issue a report to the Legislative Research Commission for
 - 7 referral to the Interim Joint Committee on Natural Resources and Energy, updating the
 - 8 General Assembly on the progress made in expediting utility pole attachment requests for
 - 9 broadband service.
- → Section 4. Whereas broadband service is critical to the economic prosperity of
- the Commonwealth, and the timetables for broadband projects funded by the BEAD.
- 12 Program and other government-funded broadband initiatives must be adhered to, an
- emergency is declared to exist, and this Resolution takes effect upon its passage and
- approval by the Governor or upon its otherwise becoming a law.
