RE: Informal Conference of June 2, 2025

Pursuant to a Staff Notice issued on May 23, 2025, an informal conference (IC) was conducted on June 2, 2025. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss Southern Madison Water District's (Southern Madison District) request for approval to use surcharge funds filed on April 30, 2025, and numerous invoices filed into the record from G.T. Construction Inc. Staff requested that Southern Madison District provide any previously missing invoices, as well as further explanation as to the repairs or work performed by G.T. Construction, the correlation with water loss reduction efforts, and any connection to the projects proposed in the qualified infrastructure improvement plan. Staff also recommended that any additional requests for approval to use surcharge funds for costs that have already been expended should be filed as separate requests in the record, should include the detailed description referenced above, and any such requests should be for reimbursement of those costs.

There being no further discussion, the IC was then adjourned.
