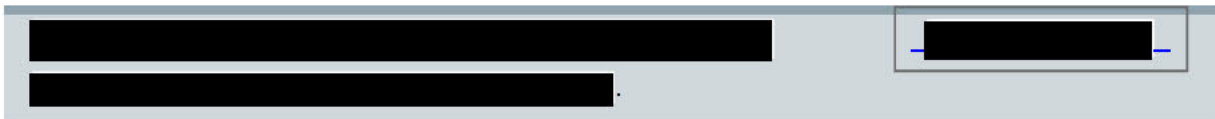

Comments: I am a residential customer of Taylor RECC. Upon reviewing the proposed rate increase schedule, I completely disagree with placing the bulk of the increase on residential customers (19.44%). Furthermore, after reviewing the analysis by Mr. Defever I question the true necessity of the increase in general. Taylor RECC has blatantly disregarded all statutes for this process, further instilling distrust in the company. Mr. Defever also discovered that Taylor RECC has increased 401k contribution to its employees to 16%, an unfounded amount in any working sector.. As far as confidentiality of employee salaries, I trust the PSC will evaluate those based on similar positions throughout the State. ROW clearing has not been performed to the budgeted amount in years, so where did that funding go? Due to reckless spending that has already taken place, I propose an independent forensic accounting audit take place to determine the shortfalls of the organization, then consider a rate increase if absolutely necessary at this time. If a rate increase is necessary, the burden should be evenly spread across more sources than residential accounts.

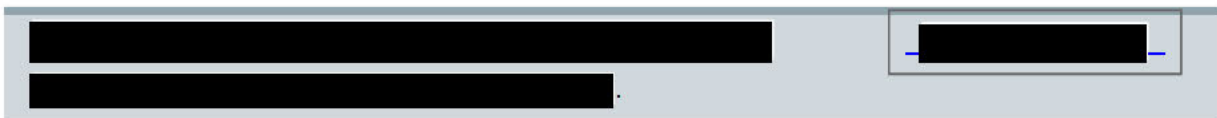

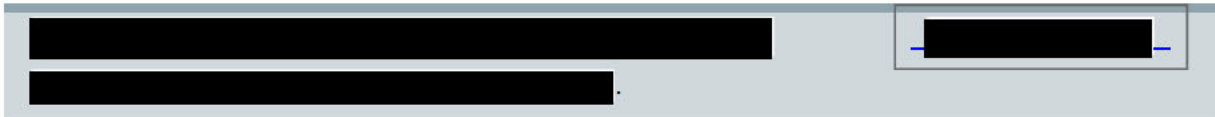

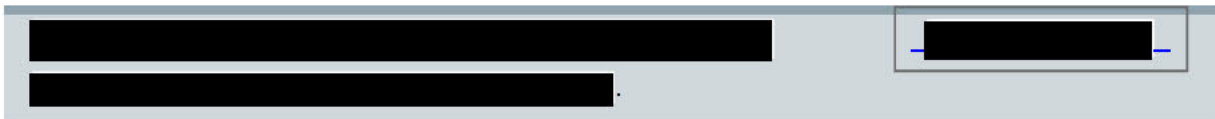
