Pursuant to an Order granting Kentucky Power Company's (Kentucky Power) motion to schedule an informal conference (IC), a video IC was held on July 10, 2023. A copy of the attendance roster is attached.

The purpose of the IC was to discuss 5 filing deficiencies in Kentucky Power's rate application submitted on June 29, 2023. Kentucky Power provided information regarding how it proposed to cure the filing deficiencies.

Commission Staff indicated that the edited documents likely cured the filing deficiencies. Additionally, Kentucky Power discussed the utility's motion for leave to deviate filed on July 7, 2023. The utility noted that they had included the wrong case information in customer's bill notice and that they intended to cure the deficiency by having the bill notice occur starting in cycle 4 of the current cycle and through cycle 3 of the following cycle.
