ORDER

This case was originally accepted for filing on July 14, 2023.<sup>1</sup> The application sought approval of Kentucky Power Company’s (Kentucky Power) proposed rate adjustments; its proposed tariffs and riders; accounting practices to establish a regulatory asset or liability; a securitization financing order; and any remaining relief required.<sup>2</sup>

The Commission issued a financing Order related to the securitization on January 11, 2024, and issued a subsequent Order on April 11, 2025. On January 19, 2024, the Commission issued its final Order related to the remaining requests and relevant issues in the case, including Kentucky Power’s proposed rates and tariff language.<sup>3</sup> Following the financing Orders and the final Order related to other issues, this matter remained open pending the completion of the financing.


