Comments: We have several issues with the pending request for a rate increase by Kentucky Power. Our account number is Account #: [REDACTED]) The account is listed in the name of Candice Hicks only which was an inadvertent mistake on her part at the time we moved into this house in December 1992. We have lived in the home consistently since that date and have been married the entire time we have lived here. We have made requests to have the name of Roger D. Hicks added to the account and have been told by Kentucky Power employees that to do so would require us to pay another deposit. We are requesting the commission to require Kentucky Power to add the name of Roger D. Hicks to the account as a joint account holder without an additional deposit being required based on the fact of our marriage and joint occupancy of the home the entire time the account has been active. 2) We have had frequent power outages ever since we have lived in the home which have extended up to 5-7 days on a regular basis. We have never seen any improvement in these outage times and have never seen evidence that Kentucky Power has done any significant repairs to the system in order to reduce or end such long and frequent outages. We believe that this failure to improve infrastructure makes Kentucky Power's request for a rate increase unjustifiable and exorbitant. 3) Nearly the entire time we have lived in this home, a total of 31 years, we have received regular periodic letters attempting to entice us into signing up for a monthly debit of \$5.00 to be placed in a Kentucky Power controlled account which ostensibly is intended for payment for repairs to the access line between our home and the nearest power pole. Kentucky Power claims the line between that pole and our meter belongs to us. But it is also a fact that Kentucky Power owns the meter and meter base which are, of course, located between said line and our house. It is only rational that Kentucky Power should be solely responsible for repairs to that line if they are also responsible for the meter and meter base. We request that the commission pass a ruling that all utilities in the state must be the sole owners of and responsible for all needed repairs to any and all equipment between their meters and the main power lines. It is our belief that this Kentucky Power owned account is simply a money grab which allows the company to use customer moneys in their "repair account" to draw interest and when those incredibly rare damages to such lines happen to "bill" that account at exorbitant rates in order to gain direct access to those customer moneys. 4) We are requesting that the commission deny the pending Kentucky Power request for yet another exorbitant and unjustified rate increase based on their inadequate responses to power outages which they do little or nothing to prevent or shorten in length. 5) While we did not fully support the recent unsuccessful attempt by a Canadian owned company to buy the assets of Kentucky Power due to their out of country ownership, we firmly believe that it is in the best interest of all Kentucky Power customers for a change in ownership of the assets of Kentucky Power. We request that the commission take appropriate actions to force a sale of all assets of Kentucky

Power to some suitable company owned and operated in the United States. Kentucky Power has proven consistently that they are unwilling to provide adequate maintenance and repairs to their equipment which would provide regular and predictable service to all customers. In a pertinent sidelight to the frequent power outages, we had a neighbor and friend, now deceased, Willie Issac, who died in April 2023 at the age of 94, whose home was located directly on US 460 near the Magoffin/Morgan County line, who suffered a 10 day power outage from Kentucky Power after the most recent ice storm. Mr. Isaac stated after that power outage that he thought he would freeze to death before his power was restored and further stated that "I won't ever go through that again. I'd rather die than freeze like that." If a 94 year old customer has actively considered suicide rather than wait for restoration of his electricity, the utility involved is unfit to serve customers in Kentucky.
