RE: City of Harrodsburg – Wholesale Water Rates

Dear Ms. Bridwell:

City of Harrodsburg, by counsel, hereby provides its notice and rate sheet for proposed increases to the wholesale water rates to Lake Village Water Association and North Mercer Water Districts. Copies of these documents are also being provided to these wholesale customers.

As you may be aware, the contracts between the City and these wholesale customers require increases to the wholesale rate when Harrodsburg's retail rates are raised. The City anticipates a commensurate 6.5% increase to its retail customers to be effective on July 3, 2023.

The Commission recently approved an increase to the City's wholesale water rates in Case No. 2022-00349. In that Order, the Commission justified its decision based on the fact that "Harrodsburg's requested increase is limited to the level of its retail water increase, is in compliance with the contracts between the parties, and an analysis evidencing support for the increase was provided." The City submitted its FY 2021 financial statements in that case.

The City can support the proposed 6.5% increase based on the more recent FY 2022 financial statements and information presented in Case No. 2022-00349. As the attached calculation shows, the City could have increased its rates by 37.09 percent. This is also consistent with the Commission's statement that "Harrodsburg also presented an analysis prepared by GRW Engineering that it could justify an increase in the wholesale water rate substantially in excess of the" amount requested in Case No. 2022-00349.

If the Public Service Commission does not receive a written request for intervention within thirty (30) days of the providing this notice, the Public Service Commission may take final action on the filing.
