Comments: To: Kentucky Public Service Commission Re: Natural Gas Issue at Fords Branch I am a seventy-three year old resident of the Fords Branch community located seven miles south of Pikeville, Kentucky. In the past, nearly forty residents including two churches and a business of this community were provided individual hookups and billed separately for their gas. Presently, those provided service from the party mentioned in the case above have been threatened with disconnects. It is obvious that our community is not a farm tap community. Demographics and limited resources make living very difficult in our area. We feel that we have been unjustly served and appreciate consideration for a fair assessment that will result in the case in question. We have been served gas for decades without this threat. That's a long time for a provider of a utility service to be "not a utility service." Thank you for your help in this matter.
