The Commission Staff has reviewed the application in the above case. This filing is rejected for the reasons set forth below.

Filing deficiencies pursuant to:

1. 807 KAR 5:063, Section 1(1)(r): A brief description of the character of the general area in which the tower is proposed to be constructed, which includes the existing land use for the specific property involved; The lot description included in Exhibit 8 does not contain a description of the character of the general area that includes existing land use. A statement is needed about the existing land use of the proposed site.
2. 807 KAR 5:063, Section 1(1)(s): A statement that the utility has considered the likely effects of the installation on nearby land uses and values and has concluded that there is no more suitable location reasonably available from which adequate service to the area can be provided; A statement is needed that the utility has considered the likely effects of the installation on nearby land uses and values and has concluded that there is no more suitable location reasonably available from which adequate service to the area can be provided, and that there is no reasonably available opportunity to co-locate, including documentation of attempts to co-locate, if any, with supporting radio frequency analysis, where applicable, and a statement indicating that the utility attempted to co-locate on towers designed to host multiple wireless service providers' facilities or existing structures, such as a telecommunications tower, or another suitable structure capable of support the utility's facilities.
3. 807 KAR 5:063, Section 1(1)(t): A map of the area in which the tower is proposed to be located, that is drawn to scale and that clearly depicts the search area in which a site should, pursuant to radio frequency requirements, be located; Map was not provided with application.

You are requested to submit the information necessary to cure the deficiencies within 10 days of the date of this letter. If you need further assistance, please contact my staff at 502-564-3940.
