**RE:** Informal Conference (IC) of September 26, 2024

Pursuant to an Order issued on August 7, 2024, a virtual informal conference (IC) was conducted on September 26, 2024. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss aspects of the Commission's June 28, 2024 final Order pertaining to Big Rivers Electric Corporation's (BREC) tariff filing to update its Large Industrial Customer Standby Service (LICSS) rates. This IC was scheduled at the request of Joint Applicants, BREC and Kenergy Corp. (Kenergy), and Joint Intervenors, Kimberly-Clark Corporation (Kimberly-Clark) and Domtar Paper Company, LLC (Domtar) in their motions filed on July 18, 2024.

Representatives of Joint Applicants and Joint Intervenors (together, "the parties") stated that they are working diligently to reach a mutual settlement agreement on tariff language that they can present to the Commission to resolve their issues. The parties requested more time to finalize their settlement agreement. Staff inquired on a reasonable timeline that the parties anticipate needing to finalize a settlement. The parties expect to have a settlement finalized and filed with the Commission 30-60 days from the filing of this memorandum. After the settlement is filed, the parties intend to request another IC to present the contents of the settlement to Staff and answer any questions Staff may have. Per Staff's request, all parties, including consultants or experts of the parties, involved in the negotiation of the revised tariff settlement will be present at the next informal conference in order to answer any questions Staff may have. The parties confirmed that the pilot tariff rates are the rates currently being charged, and the refund effective date should date back to the final Order, which was noted by the parties. No information or documents were requested by Staff during the IC.

There being no further discussion, the IC was then adjourned.
