**RE:** Informal Conference (IC) of December 12, 2024

Pursuant to an Order issued on December 4, 2024, an informal conference (IC) was conducted on December 12, 2024. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss aspects of the Settlement Agreement filed on December 11, 2024 pertaining to Big Rivers Electric Corporation's (BREC) tariff filing to update its Large Industrial Customer Standby Service (LICSS) rates. This IC was scheduled on the Commission's Order, as was previously discussed at the last informal conference once a settlement had been reached between the parties.

Representatives of Joint Applicants (BREC and Kenergy) and Joint Intervenors (Kimberly Clark Corporation and Domtar Paper) (together, "the Parties") were present to review the various sections of the settlement agreement: proposed contracts, proposed revised tariff sheets, and to answer questions from staff. The Parties stated that, if the settlement agreement is approved, they would withdraw all rehearing requests currently pending. Staff inquired as to a filing reflecting a side-by-side comparison of all major points in the final Order and the proposed settlement agreement to present to the Commission in order to better reflect the pertinent changes and to ensure that all areas of the final Order in this matter were sufficiently addressed. The parties agreed to file the requested document on the record before the end of the calendar year.

There being no further discussion, the IC was then adjourned.
