Pursuant to an Order issued on June 28, 2024, an in-person informal conference (IC) was conducted on July 2, 2024. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss aspects of the Commission's June 14, 2024 Final Order pertaining to Kentucky Power Company's tariff filing to update its Purchase Power Adjustment tariff (Tariff P.P.A.) rates and Decommissioning Rider rates. This IC was scheduled at the request of Kentucky Power Company in their motion filed on June 26, 2024. Representatives of Kentucky Power Company presented issues regarding the Final Order in this case that they requested clarification on the intent of the Commission.
