COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION  
TO HENDERSON COUNTY WATER DISTRICT

Henderson County Water District (Henderson District), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on May 30, 2025. The Commission directs Henderson District to the Commission's July 22, 2021 Order in Case No. 2020-00085<sup>1</sup> regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the

response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Henderson District shall make timely amendment to any prior response if Henderson District obtains information that indicates the response was incorrect or incomplete when made or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Henderson District fails or refuses to furnish all or part of the requested information, Henderson District shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Henderson District shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Refer to the February 2025 Water Loss Surcharge Reconciliation attachment filed on March 16, 2025. Provide an explanation for the \$5,850.27 transfer from the water loss surcharge account made on or about February 17, 2025. If used for an approved expenditure, please reference the Order authorizing the expenditure.

2. Refer to the Request to Use Surcharge Funds filed on April 25, 2025. Explain how Solid Rock Trucking, LLC (Solid Rock) was selected to perform leak

detection work and install the new zone valve. Include in the response any bids received from Solid Rock and any other vendor considered.

a. State the qualifications of Solid Rock to perform the leak detection work and the zone valve installation.

b. Explain why Solid Rock was selected for this project rather than Reveal Underground Services.

c. Confirm if the contracted leak detection services were included in the Qualified Infrastructure Improvement Plan (QIIP). If so, provide the page number the proposal for leak detection services is located.

d. If not confirmed, explain how the contracted leak detection services further the goals presented in the QIIP and provide an explanation as to why contracted services were needed.

3. State if any leaks have been found by Solid Rock; describe and demonstrate where the leaks were located; and identify any leaks which were repaired.

4. Explain how the installation of the zone valve will decrease unaccounted-for water loss.
