Case #2024-00115 KY Power DSM Case Solar panels can be safely and efficiently installed on a myriad of large-roofed buildings around the region.

Yes, I disagree with creating unsightly "solar farms" set on the ground.

On rooftops, set at effective angles, they are a brilliant energy producer with next to none of the hazards, toxins and other problems created by old fashioned power generation known for destroying vast areas of the Commonwealth's green space.

Lexington, and most other cities in the Commonwealth, have many huge warehouses built by Amazon, UPS and others that would offer great opportunities to generate green power.

Studies show that Virtual Power Plants (VPPs) are 40-60% cheaper than gas peaker plants, and deliver more benefits to ratepayers as well! We need and deserve that!

Utilities can earn a higher return on DSM investments than new generation. KPC has a chance to give their customers exactly what they need most, and make a profit doing it. We must demand that they do that.
