I am the only person in my household that works and provides income to pay the bills. We have the bare minimum and can barely afford to even buy groceries. We heat with propane and wood and don't use electric to heat with due to the costs and our home not being efficient. The home currently needs new windows which we cannot afford to replace anytime soon. My power bill was still 180.00 for 32 days of usage and for what I don't know since there's is only 3 of us in the home and we rarely do laundry and are not using electric heat at this time due to unable to afford it. Furthermore we are gone throughout the day Monday through Friday until at least 4 in the evening so I really do not understand why the power bill just seems so high. We cannot afford to continue through life in this way. I mean every bit of our income goes to bills and we can't even afford cable due to the cost being so high. We don't do many leisurely things since all the money goes towards bills and what groceries we can buy there's no room for anything else at all. Our grandchildren would love to be able to go to the movies or do something fun every once in a while but we simply have to worry about food and bills and quite frankly children just simply do not understand why they can never do anything fun. This is very heartbreaking to many families in eastern ky and I can see it everywhere and it's becoming a very sad world to live in now days. Thank you for your time in reading my voice and I truly hope this matter

will get better for the citizens and families who are tired of struggling.
