Comments: I strongly oppose the approval and construction of an industrial solar farm in Fayette County. The agriculture industry and the state itself should not be suffering a permanent loss of productive land, as the building of a solar facility with its concrete bases for support will cause irreversible damage to the soil and the lands' future use for agricultural purposes.
