Comments: Dear Sir or Madam: I oppose the construction of a solar farm on agricultural land. There is nothing green about destroying farmland with solar panels that are made in China by manufacturing plants fueled with coal--so people can pretend to care about the environment. There is also a crisis with solar panel disposal that is headed our way and recycling them is not feasible and easy as claimed. Just like plastics, they will end up in landfills. Solar panels contain toxic materials like lead and cadmium. These could potentially leech into the soil and ground water causing contamination. According to The International Renewable Energy Agency (IRENA)'s official projection, "large amounts of annual waste are anticipated by the early 2030s" and could total 78 million tonnes by the year 2050." Not very environmentally friendly. Placing these panels on agricultural land would destroy it, rendering the land useless. Additionally, this increases energy dependence on China since they are the ones manufacturing these panels--where there is little to no environmental regulatory standards as in the USA. Solar power is an unstable source of energy and is not even a viable power source for manufacturing. It also increases energy insecurity and poverty. It takes a 300 percent increase in power lines to distribute "renewable" and unstable solar energy and thus increases transmission costs. I guess that is why I have seen all the additional power lines on the

poles down Winchester Road. These new infrastructure costs will be passed on to the consumer at a time when inflation is already causing strife for Americans. For example, these "green initiatives" were implemented in California and led to an 80 percent increase in utility bills for residents--causing \$1.6 billion dollars in taxpayer subsidies to assist residents with increased costs. Tell me, how does destroying the earth while causing additional harm to the consumer help anything? Also, California has an issue with blackouts since solar and wind are unreliable! If agricultural land keeps being developed, and contaminated---then how will people eat? Where will animals in nature live? 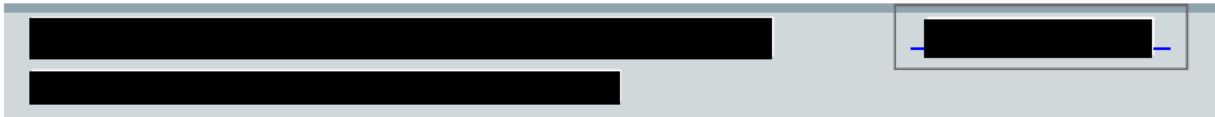
