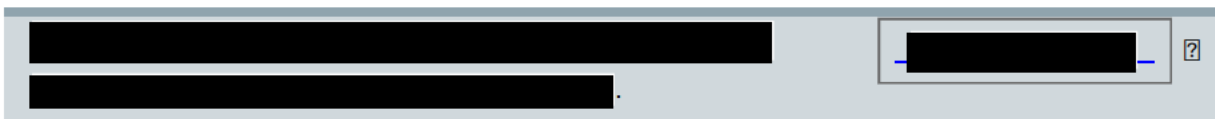

Dear Public Service Commission Board,
I would like to inform you of a situation that I feel is very important to you in making a decision on the application for this project.
There is a Texas Gas Plant that is situated right in the middle of this proposed solar project. This has large main lines coming in from the south and this plant pumps up the pressure and distributes it on to large cities including Louisville.
This plant is located at 2332 W US 60 and has proposed panels to the northwest and other panels located to the southeast. This means that all of the underground high voltage lines must installed above or below high pressure gas lines very near the plant itself because it is situated right on Hwy 60.
Another concern is the potential for a fire though rare it is a possibility. Our county has only volunteer fire departments that have limited equipment to fight this type of fire and considering the addition of a high pressure gas plant has potential for a major disaster.
I would like to ask that you consider this as a real danger to our county when deciding if this permit should be granted.
