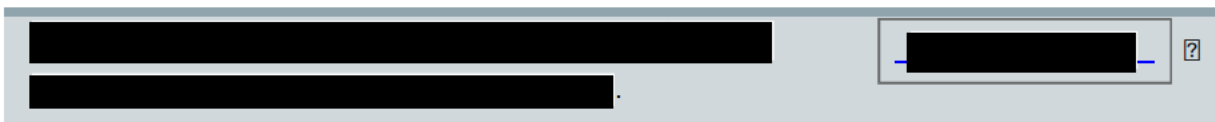

Dear Kentucky Public Service Commission,

The common wealth of Kentucky should not continue to develop infrastructure in the fossil fuel industry. Globally the industry is not a stable platform to build on.
