27. Provide how many acres of vegetation, including trees, will be cleared during construction.


You may also wish to ask for the number of acres of vegetation, including trees that **have already been cleared** in in preparation for this project.


The image below from 2022, shows that wooded area without the superimposed solar module rows.



April 12, 2025- recent view




As you can see, there has been a considerable amount of vegetation and trees removed from just this one area.
