

RE: Addendum to letter dated July 19, 2025

To Whom It May Concern:

Please accept this letter as an addendum to my letter dated July 25, 2025 in which I disclosed donations from Wood Duck to **"Beautify Barren County"** a nonprofit affiliated with Barren County Judge Executive Jamie Byrd. I failed to note a donation from Wood Duck to **"Helping the Hardworking**" another nonprofit which was founded by Byrd and of which, she was at the time of the donation, and still is, the president and treasurer according to the Annual Reports filed with the Kentucky Secretary of State's office. See attached copies.

A donation was given in November 2024 according to Wood Duck's application review, page 8 and 9, #21. See attached copy. The amount of the donation is unknown.

My previous letter mentioned donations **BEFORE** the project was approved on the local level **AND** while the project is pending approval in Frankfort. This donation was received **AFTER** the project was approved at the local level **AND** while pending in Frankfort. Byrd solicited additional funds in April 2025 per text messages to Kelley Pope, project director for Wood Duck.

I ask the citing board to consider these donations as being from a prohibited source and to eliminate the possibility of our county judge making any appointments to the Ad Hoc Committee as it will clearly taint the process. This clearly indicates a relationship that is, at the least, questionable and not indictive to an unbiased review from the county judge having received money into her personal coffers.

Now, rumor has it that the "Helping the Hardworking" is in financial ruin and the judge had to personally pay for expenses for a concert. Therefore, if true, this money was a direct benefit to the judge's repayment of said expenses. I ask the PSC and/or Attorney General's office to consider.

Continuing to accept money and continuing to solicit money from this developer is beyond staggering. This clearly shows intent to thwart public participation as our judge has told everyone from the time it was announced that it was a "done deal" refusing to inform the public there was an opportunity to participate with the PSC.

VII. Efforts to Locate Near Existing Electric Generation

22. Consistent with KRS 278.706(2)(g), Wood Duck has made efforts to locate the Project on adjoining, or in proximity to the location of existing electric generating facilities. For solar projects like Wood Duck Solar, key factors for site selection are favorable geography, willing landowner participation, and access to transmission lines. The land needed to site Wood Duck Solar was not available on or adjoining to an existing electric generation facility. However, Wood Duck selected a location in proximity to an existing transmission line. The Project's point of interconnection at the proposed Bon Avr substation located within the Project's point of interconnection at
