I Watched the Video and Caudill Stated That an Amish Man threatened the project. I am the person he is referring to and I deny this statement completely.

Wood Duck Pepsesentatives, Kelley Pope and Aaron Caudill Visited My home Sometime in early 2023 and told me They are building a Solar development. They dit Not ask me if I wanted to participate, and the only thing They told me was that the property on the east and north side of my home Would be covered in solar panels,

My property is bordered on the South by the cumberland Parkway. I learned in february 2025 (From advocates) that the proposed development would cover the properties on all sides of me except a small section of property to the west.

Atteched is a copy of a Map identifying my property and The proposed development that surrounds my Property.

When we had our first conversation, I asked about the Possibility of grazing sheep to clean the land around my Property. I had one short phone call with caudill about a week later. Later I reached out to both of them several times during that two year time frame and they Never Peturned my calls.

I Never spoke with them again until I seached on July 19, 2025, after attending the Public Meeting in Glasgow. I had some unadswered questions and tried to call both of them on the same day while I had access to a Phone.

I do not have a phone, so I walked to my neighbor's home to Malse the Calls. I called both Pope and Caudill and no answer, I called both the second time and left messages. I waited a few minutes and Called again and left a Message for both.

None of the Messages I left were threatening in any Way. I was frustrated that for two years they had Never responded to My Galls.

Shortly after the last attempt to communicate with Them, a sheriff deputy contacted me and told me I was not in Trouble, but that any further communication should be With Caudill, Attached is a copy of the Call run flespore run report from the sheriff,

Within our culture, it would be unusual for an Amish woman to have engaged in discussion about property issues, she she would have referred them to have spoken to her husband. I know of no one in the softmish community in this area that sells honey.

Thany you for the opportunity to address these mis-Pepresentations.


