Dear sitting Board Commissioners,

My name is Ernos Gingerich. I am writing to address what Geenex's employee, Aaron Caudill said about the Amish community and myself, on the stand during the recent hearing in Frankfort.

I watched the video and Caudill stated that an Amish man threatened the project. I am the person he is referring to and I deny this statement completely.

Wood Duck Representatives, Kelley Pope and Aaron Caudill visited my home sometime in early 2023 and told me they are building a solar development. They did not ask me if I wanted to participate, and the only thing they told me was that the property on the east and north side of my home would be covered in solar panels.

My property is bordered on the south by the Cumberland Parkway. I learned in February 2025 (from advocates) that the proposed development would cover the properties on all sides of me except a small section of property to the west.

Attached is a copy of a map identifying my property and the proposed development that surrounds my property.

When we had our first conversation, I asked about the possibility of grazing sheep to clean the land around my property. I had one short phone call with Caudill about a week later. Later I reached out to both of them several times during that two year time frame and they never returned my calls.

I Never Spoke With them again until I reached on July 19, 2025, after attending the public meeting in Glasgow. I had some unanswered questions and tried to call both of them on the same day while I had access to a phone.

I do not have a phone, so I walked to my neighbor's home to make the calls. I called both Pope and Caudill and no answer, I called both the second time and left messages. I waited a few minutes and called again and left a message for both.

None of the messages I left were threatening in any way. I was frustrated that for two years they had never responded to my calls.

Shortly after the last attempt to communicate with them, a Sheriff deputy contacted me and told me I was not in trouble, but that any further communication should be with Caudill. Attached is a copy of the call run response run report from the Sheriff.

Within our culture, it would be unusual for an Amish woman to have engaged in discussion about property issues. She would have referred them to have spoken to her husband. I know of no one in the ~~so~~ Amish community in this area that sells honey.

Thank you for the opportunity to address these mis-representations.

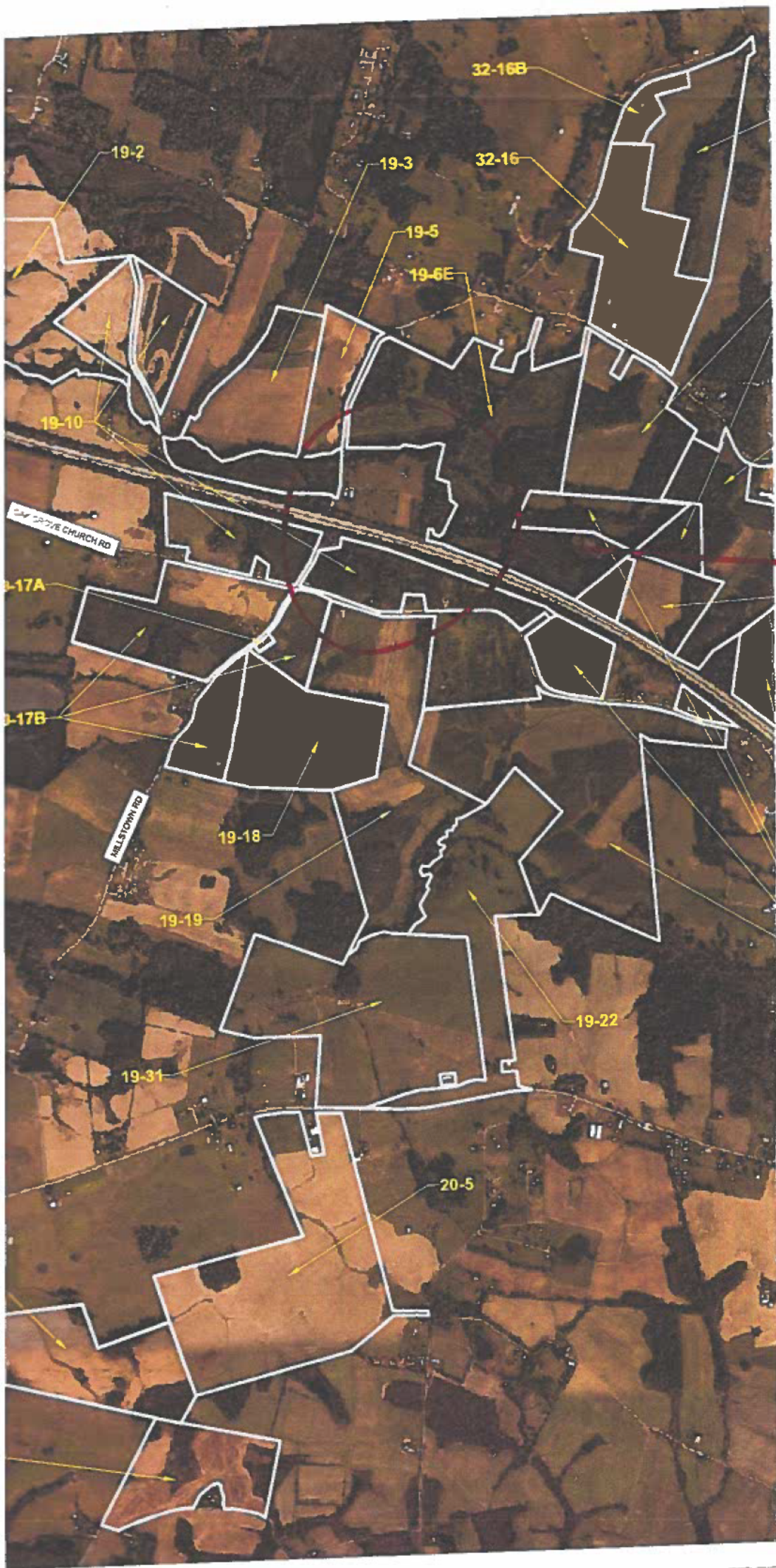
NARRATIVE

On July 24, 2025, I spoke to [REDACTED] via phone [REDACTED] provided me with the following information. She is an employee of a Geenx, Wood Duck Solar. She is working on a solar farm project in Barren County KY. She had received 2 different voicemails from who she believed to be [REDACTED], a neighbor to one of the properties where the Solar project is going to located. She stated that she had not been threatened but was concerned with some of the statements that were made. She continued that her colleague had also received voicemails from the same individual. She stated that she wished to have no further contact with [REDACTED] and if he needed anything from the company, he needed to contact her colleague. She sent the voicemails to my department issued phone and I listened to them. On one of the messages left on her phone, the person called her a derogative name. On the other, the person said [REDACTED] "don't ever answer, don't ever [REDACTED] answer". I then went to [REDACTED] I was unable to make contact with anyone at the residence.

On July 25, 2025, I went back to [REDACTED] and made contact with a family member at the residence. They stated that [REDACTED] was not at the residence but told me where I may find him. I was later able to locate [REDACTED] I played the messages for him and asked if he was the person that left the messages. He stated that he was. I explained to him that he was not in trouble at this point, but [REDACTED] requested that he not contact her anymore. He agreed to this and stated that he would have no further

contact with her. I then explained to [REDACTED] that if he had business to discuss with the company that he needs to contact [REDACTED], but it would be best to keep his communication to a professional manner. [REDACTED] agreed with this.
