Comments: January 12th, 2025 Case Number: 2024-00406 Kentucky Public Service Commission Dear Kentucky Public Service Commission, I am writing to formally express my strong opposition to the proposed 1,425-acre industrial solar energy site in Dunmor and Penrod. The development of this site would result in significant negative impacts on local wildlife, as it would entail the destruction of approximately 1,000 acres of forested land. This area is home to various wildlife species, including deer, coyotes, and foxes, as well as protected bald eagles that have been observed in the vicinity of the proposed site. Moreover, the grading of the hills associated with this project raises concerns about potential water runoff issues, which could lead to severe environmental consequences, as nearby creeks ultimately flow into the Mud and Green Rivers. Additionally, this project poses a direct threat to the property values of local landowners who have invested their

life savings into their homes and farms. Our Natural Farm stands to be affected by this solar project, jeopardizing the local environment and ecosystems. It is crucial that the rights of property owners are respected. In conclusion, utilizing previously strip-mined lands in Muhlenberg County would be a far more suitable alternative for this initiative. I strongly urge you to deny this project to protect our residents and wildlife for generations to come. If that is not feasible in any sense, then I urge the Commission to uphold the mandated 1,000-foot setback from property lines, as outlined in the KRS. Thank you for your attention to this matter.
