Dear Governor Beshear and Ms. Bridwell,

I am writing you today for clarification of content on the application for certificate of construction on the above referenced project case 2024-00406, Lost City Renewables LLC. The filed notice of intent states that the Muhlenberg Joint City/County Planning and Zoning Commission is listed as having jurisdiction of said proposed project location in the Penrod community. This proposed project does not lay within a five-mile jurisdiction of the nearest incorporated city limit, which would be Drakesboro, Kentucky approximately eight miles north of proposed construction. It is understood, by the Muhlenberg County Judge Executive and the Muhlenberg City/County Joint Planning and Zoning Committee's ordinance that the area claimed in said project, is not within the Muhlenberg County Joint Planning and Zoning Committee's jurisdiction. In light of this, I am respectfully requesting that the Public Service Commission recognize the error, and for Governor Beshear to allow the siting board position to the Judge Executive of Muhlenberg County per KRS 278.702 (1)(d).


