

Dear Members of the Public Service Commission,

I am writing to express my strong opposition to any request for a deviation from the legally mandated setback requirements under KRS 278.704 regarding the proposed large-scale solar facility by Lost City Renewables LLC in the communities of Penrod and Dunmor, Kentucky.

This project poses significant concerns for the property owners in the affected area. These include potential negative impacts on property values, risks to public health, degradation of the natural environment, and the loss of the peaceful, quiet rural character that residents have cherished for generations.

I ask you to place yourselves in the shoes of these citizens. Would you welcome the disruption of your daily life? Would you choose to live next to a massive industrial-scale facility, your view forever changed from natural forests and rolling landscapes to rows of black plastic and steel? Would you invest in land near such a development, knowing its irreversible impact on the community and its future?

The statute is clear. KRS 278.704 states:

"Beginning with applications for site compatibility certificates filed on or after January 1, 2015, the proposed structure or facility to be actually used for <u>solar</u> or wind generation shall be required to be at least one thousand (1,000) feet from the property boundary of any adjoining property owner and two thousand (2,000) feet from any residential neighborhood, school, hospital, or nursing home facility."

I respectfully urge the Commission to uphold the law and deny any request for deviation from these required setbacks. These standards exist for a reason—to protect Kentucky's citizens, their homes, their health, and the beauty of their communities.

Thank you for your attention to this matter and for considering the voices of the residents of Penrod and Dunmor.
