ORDER

On February 6, 2024,¹ Nebo Water District (Nebo District) filed its application with the Commission requesting an adjustment to its water rates pursuant to 807 KAR 5:076.

The Commission finds that a procedural schedule² should be established to ensure the orderly review of Nebo District's application. The procedural schedule is attached as Appendix A to this Order.

In addition, Nebo District shall file on or before the date set forth in the procedural schedule its responses to the Commission Staff's request for information, attached to this Order as Appendix B, and shall respond to any future requests for information propounded by Commission Staff by the date or dates set forth on any such requests.

IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in Appendix A to this Order shall be followed.

¹ Nebo District tendered its application on January 29, 2024. By letter dated February 05, 2024, the Commission rejected the application for filing deficiencies. The deficiencies were subsequently cured, and the application is deemed filed on February 06, 2024.

²No action is necessary to suspend the effective date of Nebo District's proposed rates for service. Pursuant to 807 KAR 5:076, Section 7(1), an applicant who applies for a rate adjustment pursuant to the procedures set for in 807 KAR 5:076 may not place its proposed rates into effect until the Commission approves those rates or six months from the date of the filing of its application.

- 2. On or before the date set forth in the procedural schedule, Nebo District shall file its responses to the Commission Staff's request for information, attached to this Order as Appendix B.
- 3. Nebo District shall respond to any additional requests for information propounded by Commission Staff as provided in those requests.
- 4. No later than the date set forth in the procedural schedule, Commission Staff shall file with the Commission and serve upon all parties of record a written report (Commission Staff's Report) containing its recommendations regarding Nebo District's requested rate adjustment.
- 5. No later than 14 days after the date of service of the Commission Staff's Report, each party of record shall file with the Commission:
- a. Its written comments on and any objections to the findings contained in the Commission Staff's Report; and
 - b. Any additional evidence for the Commission to consider.
- 6. If Commission Staff recommends that Nebo District's financial condition supports a higher rate than Nebo District proposes or the assessment of an additional rate or charge not proposed in Nebo District's application, Nebo District in its response to the Commission Staff's Report shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the additional rate or charge.
- 7. If Commission Staff recommends that changes should be made to the manner in which Nebo District accounts for the depreciation of Nebo District's assets, Nebo District in its response to the Commission Staff's Report shall also state its position

in writing on whether the Commission should require Nebo District to implement the proposed change for accounting purposes.

- 8. A party's failure to file written objections to a recommendation contained in the Commission Staff's Report within 14 days after the date of the filing of the Commission Staff's Report shall be deemed a waiver of all objections to that finding.
- 9. If a party requests a hearing or informal conference, then the party shall make the request in its written comments and state the reason a hearing or informal conference is necessary.
- 10. A party's failure to request a hearing or informal conference in the party's written response shall be deemed a waiver of all rights to a hearing on the application and a request that the case stand submitted for decision.
- 11. A party's failure to file a written response within 14 days after the date of service of the Commission Staff's Report shall be deemed a waiver of all rights to a hearing on the application.
- 12. As set forth in 807 KAR 5:001, Section 4(11)(a), a person requesting permissive intervention in a Commission proceeding is required to demonstrate either (1) a special interest in the proceeding that is not adequately represented in the case, or (2) that the person requesting permissive intervention is likely to present issues or develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. Therefore, any person requesting to intervene in a Commission proceeding must state with specificity the person's special interest that is not otherwise adequately represented or the issues and facts the person will present that will assist the Commission in fully considering the matter. A mere

recitation of the quantity of the utility consumed by the movant or a general statement regarding a potential impact of possible modification of rates will not be deemed sufficient to establish a special interest.

- 13. Any motion to intervene filed after the date established in the procedural schedule attached as Appendix A to this Order shall also show good cause for being untimely. If the untimely motion is granted, the movant shall accept and abide by the existing procedural schedule.
- 14. The Commission directs the parties to the Commission's July 22, 2021 Order in Case No. 2020-00085³ regarding filings with the Commission.

COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION TO NEBO WATER DISTRICT

Nebo Water District (Nebo District), pursuant to 807 KAR 5:001, shall file with the Commission an electronic version of the following information. The information requested is due on April 4, 2024. The Commission directs Nebo District to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Nebo District shall make timely amendment to any prior response if Nebo District obtains information that indicates the response was incorrect or incomplete when made

or, though correct or complete when made, is now incorrect or incomplete in any material respect.

For any request to which Nebo District fails or refuses to furnish all or part of the requested information, Nebo District shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied and scanned material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Nebo District shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

- 1. Provide copies of each of the following, and when appropriate, provide in Excel spreadsheet format with all formulas, rows, and columns fully accessible and unprotected. Employee names should be redacted from all documents.
- a. The general ledger in Excel spreadsheet format for the years ended December 31, 2022 and 2023.
- b. The trial balance in Excel spreadsheet format for the years ended December 31, 2022, and 2023.
- c. The audit adjustments for the years ended December 31, 2022, and 2023.

- d. The adjusted trial balance audited balances for the years ended December 31, 2022, and December 31, 2023.
- e. Refer to Application Schedule of Adjusted Operations. Provide a cross reference that matches each 2022 general ledger account to each revenue and expense line in the Schedule of Adjusted Operations and reconcile each amount that does not match.
- 2. Provide certificates of insurance and the most recent invoices for general liability, workers' compensation, automobile, property, and casualty for the years ended December 31, 2023, and currently.
- 3. Provide a description of all employee benefits, other than salaries and wages, paid to or on behalf of each employee for the calendar year 2022 and currently paid. Supplemental coverage for which the employee pays 100 percent of the cost should also be included. Employee names should be redacted from all documents.
- 4. Provide a copy of the most recent available invoice for each employee benefit described above.
- 5. Using a table format, provide an Excel spreadsheet with all formulas, rows, and columns fully accessible and unprotected that lists each position (Position 1, Position 2, etc.) job titles, hours worked, pay rates, total wages paid, and total FICA cost for each employee for the years ended December 31, 2022, and 2023. Additionally, provide calculations by employee that support pro forma wages of \$248,267. Include the date the employee was hired and, if applicable, the employee's termination date. If a position is recently vacated but the intent is to fill it, note the vacancy and the amount of time that it has been vacant. The table should include a column for total wages by employee

(regular wages and overtime) and a row for total wages for all employees. Employee names should be redacted from all documents.

- 6. Using the same table that lists each position and wage information, list each employee benefit (medical, dental, life, and others), the employee's contribution, the employer premium contribution, and the adjustment based on Bureau of Labor Statistics (BLS) contribution rates if applicable. If health insurance is provided designate the coverage type (i.e., single, family, couple, or parent plus). If benefits other than medical insurance are provided, include a total column for the cost of all benefits excluding the BLS adjustment.
 - 7. Provide the following information related to billing software:
 - a. Brand or common name for software.
- b. State whether the software is locally installed on a utility-owned computer or is a subscription service that is internet based.
 - c. If locally installed, state the installation date.
- d. State whether the system is still serviced by the manufacturer and whether the utility maintains a service contract.
- 8. Provide minutes from Nebo District's board of commissioner (Board) meetings, authorizing current salaries and wages for all current employees.
- 9. Refer to the Application, Schedule of Adjusted Operations, Adjustment References. Provide all workpapers used to generate the proposed adjustments.
- 10. Provide the minutes from Nebo District's Board meetings for the calendar years 2022 and 2023.

- 11. Provide a document listing the name of each member of the Board for each of the calendar years 2022, 2023, and 2024 and state, individually, the total amount of each benefit paid to, or on the behalf of, each director during each year (i.e., wages, health insurance premiums, life insurance premiums, FICA taxes, etc.), their term (beginning and ending), and current authorized annual compensation.
- 12. Provide the fiscal court minutes that authorize each Board member's appointment and compensation.
- 13. Provide training records for each Board member's initial training and for 2022 and 2023.
 - 14. Provide full asset listing for the calendar years 2021, 2022, and 2023.
 - 15. Provide the following with respect to new tap installations.
 - a. Number of installations during the test year.
- b. State whether labor costs were capitalized and, if so, provide the total amount and designate the line in the fixed assets listing that reflects the capitalization.
- c. State whether material costs were capitalized and, if so, provide the total amount and designate the line in the fixed assets listing that reflects the capitalization.
- 16. Provide an overview of any actions planned or taken by Nebo District to reduce its water loss, including a copy of any water loss reduction plan.
- 17. Refer to Nebo District's Tariff, PSC Ky. No. 2, Original Sheet No. 11, Billing, Meter Readings and Related Information, Frequency of meter reading.
- a. Provide the date that Nebo District's billing cycle begins (meter read date).

- b. State whether the date that the billing cycle begins is the date that would be best stated as the effective date of any order the Commission issues concerning rates in this case.
- 18. State the last time Nebo District performed a cost of service study (COSS) to review the appropriateness of its current rates and rate design.
- a. Explain whether Nebo District considered filing a COSS with the current rate application. If not, provide the reason for not filing a COSS.
- b. Explain whether any material changes to Nebo District's system would cause a new COSS to be prepared since the last time it completed one.
- c. If there have been no material changes to Nebo District's system, explain when Nebo District anticipates completing a new COSS.
- d. Provide a copy of the most recent COSS that has been performed for Nebo District's system in Excel spreadsheet format with all formulas, rows, and columns fully accessible and unprotected.
- 19. Refer to the Application, Current Billing Analysis 2022 Usage and Existing Rates and Proposed Billing Analysis 2022 Usage and Proposed Rates. Provide the billing analysis in Excel Spreadsheet format with all formulas, rows, and columns unprotected and fully accessible.
- 20. Provide the number of occurrences and dollar amounts for late fees that were recorded during the calendar years 2022 and 2023.
- 21. Provide a schedule listing the number of occurrences for each nonrecurring charge that were recorded during the test year and the total amount recorded for each nonrecurring charge. If the revenue for any nonrecurring charge was zero, include that

charge and indicate that no revenue was recorded. Include the general ledger account numbers where each nonrecurring charge is recorded.

- 22. Provide updated cost justification sheets to support each nonrecurring charge listed in Nebo District's tariff.
- 23. Provide updated cost justification sheets to support each Meter Connection/Tap-on Charge listed in Nebo District's tariff.
- 24. Refer to the Application, Attachment 3, Current and Proposed Monthly Rates, and the current tariff on file with the Commission. Explain why the 3-inch meter tier is not included in the Current and Proposed rate schedule.
- 25. Refer to the Application, Attachment 5, Current Billing Analysis. Provide the meter size of the Fire Hydrant section.
