
IT IS THEREFORE ORDERED that:

4. All parties shall file any post-hearing response briefs, should they choose to do so, addressing only issues raised in initial briefs on or before January 27, 2025.
5. This case shall stand submitted for a decision by the Commission effective 12:01 a.m. Eastern Standard Time, January 28, 2025.

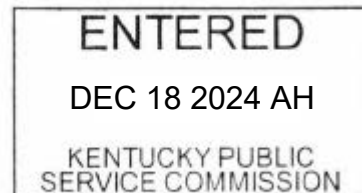
