## ORDER

On December 30, 2024, the Commission issued a final Order in Columbia Gas of Kentucky, Inc.'s (Columbia Kentucky) application for a general rate adjustment. The Order contained a typographical error in Rate Schedule IUS, total billing rate. In addition, the Balancing Charge for Rate Schedule SVAS did not account for the most recent gas cost adjustment approved by the Commission.

Finding that the December 30, 2024, Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. Rate Schedule IUS in Appendix C, page 1 of 3, total billing rate of \$5.7106 is stricken and is replaced with the following language:

Total billing rate of - \$5.7100

2. The Balancing Charge per Mcf for Rate Schedule SVAS in Appendix C, page 3 of 3, of \$1.1130 is stricken and is replaced with the following language:

Balancing Charge per Mcf \$1.2231

3. All other provisions of the Commission's December 30, 2024 Order that are not in conflict with the terms of this Order shall remain in effect.
