ORDER

On May 15, 2024, Pike County Solar, LLC (Pike County Solar) filed its application in this case, together with the \$100,000 application fee, as required by KRS 278.706(5) and 807 KAR 5:100, Section 5. The fee was acknowledged by letter from the Kentucky State Board on Electric Generation and Transmission Siting (Siting Board) dated May 14, 2024. On November 15, 2024, the Siting Board issued an Order granting a Conditional Certificate of Construction. As of February 13, 2025, the Siting Board had accrued \$117,637.24 in case-related expenses, for a shortfall of \$17,637.24 as of that date. KRS 278.706(5) provides, "If a majority of the members of the board find that an applicant's initial fees are insufficient to pay the board's expenses associated with the application, including the board's expenses associated with legal review thereof, the board shall assess a supplemental application fee to cover the additional expenses." The Siting Board, therefore, finds that Pike County Solar should pay an additional amount totaling \$17,637.24 as a supplemental application fee for expenses already incurred and estimated to be incurred.

IT IS THEREFORE ORDERED that:

1. Pike County Solar is assessed a supplemental application fee of \$17,637.24.

2. Pike County Solar shall remit payment to the Siting Board within 15 days of the date of service of this Order.

3. The payment shall be a certified check or money order made payable to the Kentucky State Treasurer that is delivered or postmarked as mailed to the Office of General Counsel, Public Service Commission, P.O. Box 615, Frankfort, Kentucky 40602-0615, before the deadline.

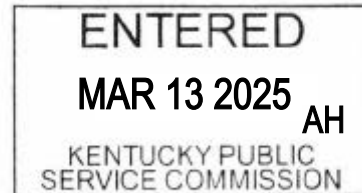
