ORDER

On June 24, 2024, Mountain Association, Appalachian Citizens' Law Center, Kentuckians for the Commonwealth, and Kentucky Solar Energy Society (jointly, Joint Intervenors) filed a motion asking the Commission to amend its May 30, 2024 Order setting a procedural schedule. Joint Intervenors sought to set deadlines for intervenor testimony and related discovery. The May 30, 2024 Order contemplated such an amendment in the event intervenors joined the case and wanted to provide testimony.¹

Joint Intervenors provided a proposed amended procedural schedule.² Kentucky Power Company (Kentucky Power) did not file a response to Joint Intervenors' motion within the time allowed by 807 KAR 5:001, Section 5(2).

The Commission finds that Joint Intervenors' motion to amend the procedural schedule should be granted. A new procedural schedule setting forth additional dates for intervenor testimony and rebuttal is attached as an Appendix. The previous procedural schedule is vacated to the extent that it conflicts with the procedural schedule set forth in the Appendix to this Order. All other provisions of the May 30, 2024 Order should remain in effect.

IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in the Appendix to this Order shall be followed.
2. The procedural schedule set forth in the Commission's May 31, 2024 Order is vacated to the extent that it conflicts with the procedural schedule set forth in the Appendix to this Order.
3. All other provisions of the May 30, 2024 Order shall remain in effect.

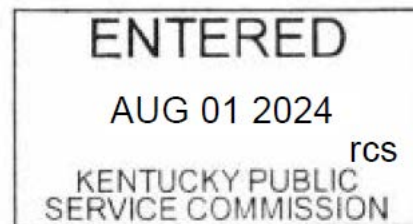
