<u>ORDER</u>

On May 30, 2024, the Commission issued an Order in this matter directing East Kentucky Power Cooperative, Inc. (EKPC) to respond to data requests by June 5, 2024. By Order dated May 14, 2023, the Commission issued a procedural schedule establishing a data request response due date of June 12, 2024. On May 30, 2024, EKPC sought clarification of the discrepancy and requested the data response due date to be June 12, 2024.

Finding that the May 30, 2024 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. The following is stricken: "The information requested is due on June 5, 2024." and is replaced with the following language:

"The information requested is due on or before June 12, 2024."

- 2. All other provisions of the Commission's May 30, 2024 Order that are not in conflict with the terms of this Order shall remain in effect.
- 3. Given that the May 30, 2024 Order is hereby amended *nunc pro tunc*, EKPC's motion for clarification is denied as moot.
