ORDER

On November 1, 2024, Sierra Club moved the Commission to admit *pro hac vice* Nathaniel Scoaff, an attorney whose office is in California, and Kristin Henry, an attorney whose office is in California to practice law before the Commission on behalf of Sierra Club, in association with Joe Childers, an attorney licensed to practice law in the Commonwealth of Kentucky, in this case. 


