ORDER



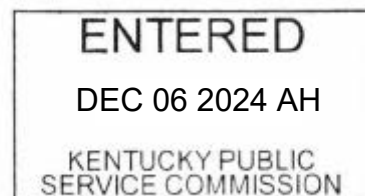
