ORDER

On December 2, 2024, Kentuckians for the Commonwealth (KFTC), Kentucky Solar Energy Society (KYES), and Kentucky Resources Council (KRC), (collectively Joint Intervenors) moved the Commission to admit *pro hac vice* Cassandra McCrae, an attorney in good standing in the state of Pennsylvania and Texas and certified to practice law before the Commission, in this case by the Kentucky Bar Association under Supreme Court Rule 3.030(2).¹ In addition, Cassandra McCrae has agreed to be subject to the jurisdiction and rules of the Commission and the Kentucky Bar Association.


