## ORDER

By Commission Order issued August 15, 2024, a hearing was previously set in this matter for December 11, 2024, and December 12, 2024. On November 14, 2024, Warren County Water District (Warren District) filed a motion to proceed without a hearing in this matter. Warren District stated that there are no intervenors in this proceeding; that it has responded to three requests for information; it has no new information to provide the Commission at a formal hearing; and waives its right to a formal hearing in this matter. Warren District further stated, in lieu of a hearing, it would participate in an Informal Conference (IC) with Commission Staff, if beneficial.

Having considered the motion, the Commission finds that Warren District's motion to proceed without a hearing should be granted. The Commission finds good cause to cancel the hearing in this matter, as any further information necessary for the Commission to issue its decision can be obtained through further requests for information or an IC, and in order to conserve the time and resources of the parties, counsel, and the Commission. The Commission further finds that the record should remain open for Commission Staff to issue any further necessary requests for information or to schedule an IC with Warren District.

## IT IS HEREBY ORDERED that:

- 1. Warren District's motion to proceed without a hearing is granted.
- 2. The hearing previously scheduled in this matter for December 11, 2024, and December 12, 2024, is canceled.
- 3. Warren District shall respond to any further requests for information from Commission Staff or participate in any scheduled IC.
