ORDER

The Commission, on its own motion, HEREBY ORDERS that:

1. A hearing in this matter shall be held on Tuesday, February 4, 2025, at 9 a.m. Eastern Standard Time and continue until called from the bench by the presiding officer, at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.

2. Licking Valley Rural Electric Cooperative Corporation's (Licking Valley RECC), who is a party to this proceeding, and the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), who is an intervenor, shall appear at the February 4, 2025 hearing to provide testimony regarding the subject matter of this proceeding.

3. Pursuant to 807 KAR 5:001, Section 2, if the hearing is not concluded on the designated day, the hearing may be continued upon verbal announcement by the presiding officer. A verbal announcement made by the presiding officer shall be proper notice of the continued hearing.

4. Witnesses who sponsor schedules, testimony, or responses to requests for information shall participate in person at the February 4, 2025 hearing.

5. Licking Valley RECC and the Attorney General shall file a witness list at least seven days prior to the hearing date.

6. Licking Valley RECC shall give notice of the hearing in compliance with 807 KAR 5:001, Section 9(2)(b). In addition, the notice of hearing shall include the following statements: “This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov” and “Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listed on the PSC website, psc.ky.gov.” At the time the notice is mailed, or publication is requested, Licking Valley RECC shall forward a duplicate of the notice and request to the Commission.

7. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video transcript shall be made of the hearing.

8. Licking Valley RECC and the Attorney General’s joint motion¹ to amend the procedural schedule found in the August 16, 2024 Order,² to allow the parties to submit simultaneous briefs, and allow the matter to be submitted on the record after the briefs are filed is denied.

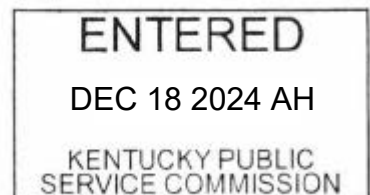
